- 4. Lead a church meeting to discuss options.



#### FOR ALL GOD'S PEOPLE

The Global Methodist Church will welcome all people regardless of their background in order that they might experience the grace and love of Jesus Christ. The GMC believes "human sexuality is a gift of God to be affirmed as it is exercised in the spiritual covenant of a loving and monogamous marriage between one man and woman". As God's people, "we welcome all to experience the redemptive grace of Jesus and are committed to being a safe place of refuge, hospitality, and healing for any who may have experienced brokenness." The church is "called to be faithful to the example of Jesus' ministry to all persons" so that all might experience God's salvation and work toward holiness.

Will the Global Methodist Church ordain those professing to be active gay or lesbian pastoral candidates? Will clergy be allowed to perform same-sex marriages?

Those not living by the standard in The Transitional Book of Doctrines and Disciplines will not be ordained as clergy in the GMC. Additionally, GMC clergy are not permitted to perform same-sex marriages.

#### What about Peeps and Magi programs?

They will continue to operate just as they do today. A new church name will be created. All of the state agencies and everyone we conduct business with will be legally and properly notified of the new church name. The transition will be seamless.

#### What about the Salkehatchie program?

Salkehatchie is its own entity and does not receive apportionments from the UMC. Our church will still be able to host and support Foothills Salkehatchie.

The following two statements are unanimously agreed upon from both....

- The Way Forward Committee and
- Making a Way Committee

1. We believe the U.S. United Methodist Church is past the point of further debating whether we should change the wording in the Book of Discipline to allow same sex marriages and ordaining LGBTQ+ professing pastors. With so many conservative churches having already left the denomination and many others on a path to leave soon, there is every reason to believe they have the votes to make significant changes. These changes will clearly alter the values and theology we have historically protected.

2. We believe that for our PUMC family to remain together, have ownership of our property, continue serving our local ministries and mission to know Christ and make Christ known, we will have to **separate** from the United Methodist Church and join the Global Methodist Church. This is our best opportunity to remain who we are. We believe we are prepared to make that move with no disruption among our general membership and day-to-day activities.
